

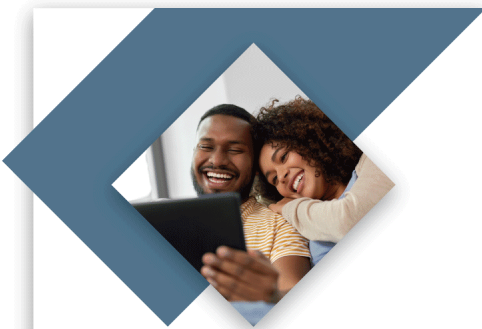

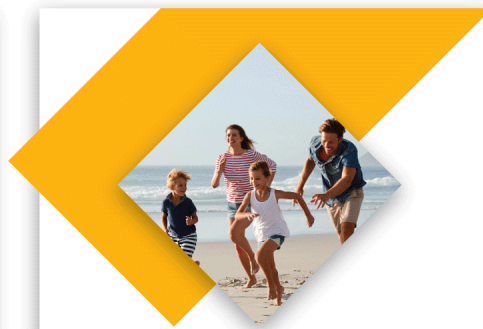

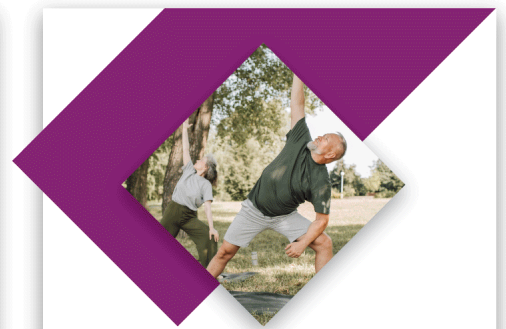
#### Traditional Savings Account
